Wisconsin Center District COVID-19 Visitor Guidelines

Welcome to the Wisconsin Center District, owners and operators of the Wisconsin Center, Miller High Life Theatre, and UW-Milwaukee Panther Arena. We are proud to be open for business with the health and safety of all as our top priority.

Please review the protocol and guidelines below regarding safe entry and exit into the WCD buildings. All scheduled guests, WCD staff, Levy foodservice staff, and outside contractors are required to adhere to the WCD's health and safety guidelines.

Entering the Wisconsin Center

- All individuals should self-test temperature daily before and after work to assist with the self-screening process. If your temperature is 100.4 F or greater please do not enter the Wisconsin Center.
- If you believe you have been exposed to COVID-19 and/or are exhibiting symptoms, get tested and do not come to the Wisconsin Center.
- All guests and staff should enter the Wisconsin Center at the staff entrance located at 750 North 6th Street, which is between Wisconsin Avenue and Wells Street. All other access points have been removed from access cards.

Health Screening

Once inside the Wisconsin Center employee entrance you will be given a daily health screening. The results of your screening are confidential and are held in the WCD HR department. Administered by a third-party service, the screening includes the following:

- You will be asked six standardized health questions
- Your temperature will be recorded by a touchless thermometer. If your temperature is at or above 100.4 degrees F and/or you have symptoms determined through the six screening questions, you will be taken to a secondary screening location where you will receive a mask and gloves. There, a second temperature screen will be administered. If your temperature is below 100.4 degrees F you will be permitted to enter. If above, you will be asked to exit and either head home or to a medical facility.
- Any refusal of screening, individuals will not be permitted to enter.

Personal Protective Equipment (PPE) and Sanitization

All guests and WCD staff must wear a face mask at all times, unless alone in a single work space. Please bring your own mask, but know that the WCD does have disposable masks available for your use if needed. Throughout the buildings, common areas are marked with occupancy limits, chairs have been removed to limit the occupancy in shared spaces, and physically distanced markers line hallways. Please adhere to these guidelines.

The WCD has implemented an even more rigorous cleaning regimen, which is marked on cleaning sheets in shared spaces including restrooms. Hand sanitization stations are amply available throughout the buildings and we encourage frequent hand washing with the touchless faucets in our restrooms. Commonly used doors have been equipped with touchless access plates (using your foot).

Meeting together while physically distancing can be challenging, but WCD buildings have the space to make it work. WCD has worked closely with city, county, state, and national leaders to set the standard for safety and cleaning expectations. The staff have easily acclimated to these safety standards and assure you that they are a simple and reliable way to feel safe while meeting in person. We can't wait to see you in the building.
